

# The U.S. Constitution

It's Statement of Intent + Articles + Amendments that create the **USA's Rules of Law** (Not available in any U.S. University -or- U.S. Law School -or- U.S. Political Party's HQ -or- PAC)

**"...with liberty and justice for all."**

Depends on U.S. citizens having equitable options and opportunities and being treated equally by the Law, as-written, in the U.S. Constitution — a Principle-based **Contract** between Americans and their-Government.  
**The USA today =>**

**The Preamble:** The Preamble does not, in itself, have substantive legal meaning, and should-be read as defining rather than granting power. Jacobson v. Massachusetts (1905). Combined with the U.S. Declaration of Independence testifies to the Intent of the U.S. Constitution.

*"We the People of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defense, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America."*

The Rules of Law excerpted from the U.S. Constitution as applicable to "abortion" and other Societal aberrations of Special Interests.

**Article I: Clause I:** *"...not pass any Bill of Attainder, ex post facto Law, or Law impairing the Obligation of Contracts..."*

The State of Florida has no legal claim to the Land that the State of Florida occupies. When Florida was accepted as a State into the USA it signed a-Contract to respect, support and comply with the U.S. Constitution as a Condition of Affiliation. Violation of the U.S. Constitution constitutes a Breach of Contract that could return Florida to Territorial Status.

**Article IV: Section 2:** *"The Citizens of each State shall be entitled to all Privileges and Immunities of Citizens in the several States"*

Support for current religious based anti-abortion laws requires an Amendment to the US Constitution. America's KJB Christians gave America the 18th Amendment while American Capitalism gave America the Roaring 20s. How did that work out?

**Article VI: Clause 2:** *"This Constitution, and the Laws of the United States which shall be made in Pursuance under the Authority of the United States, shall be the Supreme Law of our Land"*

**Amendment 1:** *"Congress shall make no law respecting an establishment of religion..."* The grounds for anti-abortion legislation are an attempt to make KJB Christians' religious beliefs the Law of our Land. Their biblical-based contentions violate the physical Process of Human Procreation + Medical Science + Reality. An Embryo and an early Fetus have no independent heart. The ultra-sound tones are from the Mother's umbilical cord that is connected to her Placenta, which is connected to a Fetus that is not defined scientifically as a potential living entity until about 5 months of development. **Amendment V:** Due Process Clause requires the United States government to practice equal protection. *"...nor shall private property be taken...without just compensation."* Private Property = something that belongs exclusively to a specific person who has the-Right to treat or dispose-of their property as they decide as long as their decision does not interfere with the Constitutional Rights of their fellow Citizens. A embryo/fetus is not a citizen and subject to Statute/Civil Law until the mother's umbilical cord is cut. Until the mother's umbilical cord is cut, the potential citizen is a Mother's Private Property. Therefore, an anti-abortion State violates a Mother's Private Property Rights and that State must financially support an abortion-prevented Mother and her child throughout her child's dependency.

**Amendment VI:** *"In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of and to have the Assistance of Counsel for his/her defense"*

**Amendment VII:** *"In Suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved, and no fact tried by a jury, shall be otherwise re-examined in any Court of the United States, than according to the rules of Common Law that reflect the supreme Law of the Land"*

**Amendment VIII:** *"...nor cruel and unusual punishments inflicted."* = As in Mandatory attendance to U.S. failing schooling posing as an Education.

**Amendment IX:** *"The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage other Rights retained by the people"* (in the Preamble and the U.S. Declaration of Independence)

**Amendment X:** *"The powers not delegated to the United States by the Constitution are reserved to the States respectively or to the people."* (Powers and Rights are not synonyms. Powers are granted by a superior Power and can be modified or rescinded. Rights are inalienable and guaranteed by the U.S. Constitution's Articles and Amendments, not by Judicial Fiat.)

**Amendment XIII: Section 1:** *"Neither slavery nor involuntary servitude shall exist within the United States, or any place subject to their jurisdiction."* (Compulsory school attendance to U.S. failing Schooling Matrix K-20; Anti-abortion.)

**Amendment XIV: Section 1:** *"All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws."*

**Section 3:** *"No person who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof is eligible to hold public office."*
